<small>Article III, Section 2 of the FLC Foundation Bylaws of 6/7/1985 (as amended) specifies that the Board of Directors will consist of a minimum of three and a maximum of nine members, each of whom will serve a three-year term. Article III, Section 3 specifies that the pastors of First Lutheran Church will serve on the Board as Ex-Officio, Non-Voting Directors, and shall be reappointed annually as long as they are in that position. Article IV, Sections 1 and 2 specify that the Board will include four elected officers (President, Vice President, Treasurer and Secretary), who will be elected annually from the</small>
